**CALL TO ORDER**

Mayor Billy McHone called the meeting to order and Council Member Mark Baker gave the invocation. The following elected officials and staff were present: Mayor Billy McHone, Mayor Pro Tem Myron Marion, Council Members Mark Baker and Lori Shore-Smith, Attorney Amy Lanning, Administrator Dan Corder and Clerk Robin Key. **APPROVAL OF MINUTES**

Council Member Shore-Smith made a motion to approve the December 1, 2011 Council Meeting Minutes. Mayor Pro Tem Marion seconded the motion. The vote was unanimous.

**FINANCIAL REPORT**

Administrator Corder reviewed the November financial report. Mayor Pro Tem Marion conducted an internal audit of the records and found no discrepancies. (Attached)

**DISCUSSION TO AMEND CURRENT ORDINANCE#24 REGULATING POSSESSION OF WEAPONS ON VILLAGE-OWNED PROPERTY**

Current Ordinance #24, dated October 30, 1995, is in conflict with House Bill 650 (Session Law 268) enacted by the General Assembly in its 2011 session which changed a number of provisions related to the use of firearms. After discussing the issue, Mayor McHone made a motion, rather than amend Ordinance #24, to repeal Ordinance #24 and incorporate additional provisions F & G into a new Ordinance #137 as presented by Attorney Lanning. (Attachments) The vote was as follows: YES – Mayor Billy McHone, Mayor Pro Tem Myron Marion, and Council Member Lori Shore-Smith; NO – Council Member Mark Baker. The motion carried by majority.

There was a consensus of the Council to hold a Budget Workshop Meeting in the Conference Room at Village Hall at 6 p.m. on February 2, 2012 prior to the regularly scheduled February Council Meeting.
